



Terms & Conditions

Non-Refundable: All payments to Burch Travel LLC are non-refundable and non-transferable. We highly recommend that you take out insurance to provide adequate coverage for medical expenses, personal accident, loss of baggage and curtailment or cancellation of trip.

Travel Protection: We highly recommend you protect your travel investment with insurance. In most cases Burch Travel may be able to provide you with a quote and add insurance to your booking. It is your responsibility to be familiar with the insurance coverage purchased and ensure that the coverage meets your travel needs. Insurance must be purchased and paid for in full as soon as the booking is made to become fully effective.

Cancellation: Should you need to cancel a reservation that has been made and deposited, your cancellation request must be submitted in writing to info@burchtravel.com. If you do not receive a response from us within 48 hours, please contact us at 407-900-9787 to make sure we received your request.

Acceptable forms of Payment: Major Credit Cards, Debit Cards or Money Order. We do not accept cash or checks. If paying by money order, make funds payable to Burch Travel LLC, 1969, S. Alafaya Trail, Suite 234, Orlando, FL 32828

Reservation Changes: There is a \$50 per person charge for any deposited reservation changes plus any fees incurred by the supplier(s).

Baggage Policy: Many airlines have instituted a policy of charging travelers for checked baggage and/or carry-on baggage. Those charges are payable directly to the airline at the time of check-in, and as a result, are not included in the price of your vacation. Baggage policies are subject to change without notice. Please contact your airline or refer to its website for detailed information regarding their checked baggage policies.

Passports: All individuals departing from the United States of America must be in possession of a valid passport. It is your responsibility to ensure that you have valid travel documentation, including but not limited to passports and visas, which meet the requirements of immigration and other government authorities at every destination. You are responsible for confirming with the United States Department of State or representative government agency of the country to which you are traveling to confirm the requirements for visas and/or other requirements for admission to your destination. Any fines, penalties, payments or expenditures incurred as a result of such documents not meeting the requirements of those authorities will be your sole responsibility. Passports must be valid at least six months beyond your travel dates and have two or more blank pages. Though some “closed-loop” cruises may not require a U.S. passport, we recommend bringing yours in case of an emergency, such as an unexpected medical air evacuation or the ship docking at an alternate port in an emergency. A government issued ID is required for travel within the USA. All names on documents must match the legal name on your photo I.D., and travel document information must match tickets. Please check the State Department website at <https://travel.state.gov> for further information.

Health and Special Requirements: It is your responsibility to ensure you are aware of any health requirements for your travel destinations and to ensure that you carry all necessary vaccination documentation. Please advise your consultant of any special requirements you may have, for example, special meals, medical requirements and so on.
